What Is The Source?

The nutrients found in PediaNutrients® are derived from the following:

- Mixed carotenoids: *D. salina* (algae)
- Vitamin C: corn dextrose fermentation
- Vitamin E: soybean
- Vitamin D₃: cholesterol from wool fat (lanolin)
- Vitamin B₁ (thiamine HCl): synthetic
- Vitamin B₂ (riboflavin): corn dextrose fermentation
- Niacinamide: synthetic
- Vitamin B₅ (calcium pantothenate): synthetic
- Vitamin B₆ (pyridoxal HCl): synthetic
- Vitamin B₁₂ (methylcobalamin): corn dextrose fermentation
- Folic acid: synthetic
- Biotin: synthetic
- Minerals: naturally derived from earthen ore

Sources of the mineral chelates include:

- Aspartate: soy protein hydrolysis
- Citrate: corn dextrose fermentation
- Glycinate: synthetic
- Polynicotinate: synthetic

Hypo-allergenic plant fiber is derived from pine cellulose.

There is no detectable GMO material in this product.

Recommendations

Pure Encapsulations recommends 2-4 capsules per day, in divided doses, with meals.
